Below, you will find more information on the processing of personal data for the following scientific research project:

#### Title of the research project

The Dark and the Light: How dark and light triad CEOs influence their organizations.

## Description of the research project

In this study we aim to study how light (e.g., empathy) versus dark (e.g., narcissism) CEO characteristics affect the organization's payment structure of top executives in large U.S. firms.

Existing dataset Tilburg University (Execucomp)

Existing public dataset third party (Youtube and other public video places like the company website)

## Which data subjects are involved in the research?

In this study we focus specifically on chief executive officers (CEOs) of large U.S. (S&P 500) firms

## What personal data are used?

We collect videos from CEOs which external raters are then rating on dark and light triad personality traits.

We also collect (from TiU approved databases, namely Execucomp) public data from the CEO, like the person's gender, age, and payment structure according to their company's 10-K filing. There is no sensitive data collected

## Which safeguards are in place for this research project?

#### Ethical assessment

The research protocol was approved by the Review Board of Tilburg School of Economics and Management under application number EXP 2024-001.

Tilburg University uses secure applications/methods.

### Will data be disclosed to third parties, and if so, to which parties?

Data will not be disclosed to third parties.

#### How long will the data be stored?

10 years for the purpose of further scientific research

Research data is anonymized as soon as possible and stored for 10 years to ensure scientific integrity.

The following identifying data are stored separately also for 10 years: snippets of videos from Youtube or other public websites.

Once data has been anonymized, it cannot be traced back to you, and this privacy statement no longer applies.

#### Your rights

You have the right to request access to your data and to ask for the rectification or erasure of your data. You also have the right to obtain a restriction of or object to the processing of your personal data.
